**Important Notes :** 1. The total number of sections of the school shall be restricted to 13 and the number of students in 2 class rooms which are 400 to 500 ft in dimension shall be restricted to 35 and further increase shall be subject to specific approval of the Board on the basis of the request of the school as per affiliation bye laws subject to the availability of rooms of >500 ft dimension.

2. The school has three sides of boundary wall and some part of the same is less than 6ft and partly covered with tin shed. Further, fourth side is covered with tin sheet. The school is directed to construct the pucca concrete boundary wall from all four side with minimum 6 ft of height and submit the videography link

- er the complete boundary wall in continuity along with aerial view within 03 months in compliance on SARAS portal.
- The fire safety certificate submitted by the school, does not match the land certificate (difference in plot/khasra numbers). The school shall submit the fire safety certificate with the correct land details, matching the land certificate within 3 months on SARAS portal.
4. The school is required to construct covered toilets in the school building with proper partition in the urinals within 3 months and submit the compliance on SARAS portal.
5. The school is required to construct the ramp/lift to access first floor and separate toilets for boys and girls on each floor for CWSN with proper infrastructural facilities in accordance with the provisions laid down in RPWD Act and Board's guidelines ([https://saras.cbse.gov.in/SARAS/Circulars/Circular05\\_2023.pdf](https://saras.cbse.gov.in/SARAS/Circulars/Circular05_2023.pdf)), within 3 months and submit the compliance.
6. The library is undersized. The stock registers of the lab and the library have not been maintained by the school. The playground is not levelled / developed and Outdoor game facilities are inadequate. Further, the school has live specimens in the composite science lab which is prohibited. Thus, the school is required to upgrade said labs and game facilities as per the Board's Sop ([https://saras.cbse.gov.in/SARAS/Circulars/Circular11\\_2022.pdf](https://saras.cbse.gov.in/SARAS/Circulars/Circular11_2022.pdf)), within 3 months and submit the compliance.
7. The school is required to appoint special educator and implement the EPF facilities for all the staff members within 3 months and submit the compliance.
8. The school shall conduct training of its teachers with COE Bhubaneswar within 3 months and submit the compliance.
9. The school shall not remove the videography links in the mandatory disclosure section of its website and renew all mandatory certificates from time to time.
